# Monoclonal Antibody (mAb) Treatment Funding



### HSCRC Program Funding will support Monoclonal Antibody Treatment

- The HSCRC COVID-19 Community Vaccination Grant Program has been expanded to allow awarded funding to cover mAb treatment related costs.
- Participating hospitals will be able to partner with MDH to identify and target patients who
  may benefit from mAb treatment.
- This new allowable use of existing funding is a continuation of our vision to use the COVID-19 vaccine infrastructure hospitals have started to create in communities and apply it to other areas of need.
- In addition to addressing the public health crisis that COVID-19 has created, this program is also consistent with our Total Cost of Care Model goals to reduce unnecessary ED utilization and other potentially avoidable utilization.
