Re: Rate Center Reconciliations Reports for FY10

Rate Center Reconciliations Reports of FY10 quarters 1-3, Inpatient and Outpatient case mix data versus financial data for the same period, by hospital, are due to the Commission by **Wednesday, July 28 2010**.

The charges and units by rate center reported on the Inpatient and Outpatient data tapes should match the same information reported in the financial data. The optimal rate center volume and revenue reconciliation would be within +/- 1%. However, we do recognize that this may be difficult due to the size of some revenue centers; therefore, staff will review and take into consideration explanations for any discrepancies greater than +/- 1%.

Attached to this memorandum is a Rate Reconciliation Report Template. Please submit the reconciliation reports and explanations using this format (i.e., EXCEL). Reports in other formats with not be accepted and will be returned to the hospital.

- On the first 2 sheets (Q1 Inpatient, Q1 Outpatient) in the workbook, please copy and paste the charges and volumes (case mix versus financials) for inpatient and outpatient for FY10 Quarter 1 only. For each rate center that is outside the +/-corridor, please provide an explanation in the last column, titled "Variance Explanation."
- On the next 2 sheets in the workbook (Q2 Inpatient, Q2 Outpatient), please copy Toll Free 1-877-4MD-DHMH · TTY for the Disabled Maryland Relay Service 1-800-735-2258

and paste the charges and volumes (case mix versus financials) for inpatient and outpatient for **FY10 Quarter 2 only**. For each rate center that is outside the +/-corridor, please provide an explanation in the last column, titled "Variance Explanation."

- On the next 2 sheets in the workbook (Q3 Inpatient, Q3 Outpatient), please copy and paste the charges and volumes (case mix versus financials) for inpatient and outpatient for FY10 Quarter 3 only. For each rate center that is outside the +/-corridor, please provide an explanation in the last column, titled "Variance Explanation."
- When Quarter 4 Inpatient and Outpatient data becomes available, please insert the charges and volumes (case mix versus financials) for inpatient and outpatient for FY10 Quarter 4 only in the Q4 Inpatient and Q4 Outpatient tabs. For each rate center that is outside the +/- corridor, please provide an explanation in the last column, titled "Variance Explanation."
- On the last 2 sheets, please combine FY10 Quarters 1-3 (and 4 once its available) charges and volumes (case mix versus financials) for inpatient and then for outpatient. For each rate center that is outside the +/- corridor, please provide an explanation in the last column, titled "Variance Explanation."

If your hospital does not have charges or volumes for a particular rate center enter "0" for volumes and charges.

If the variance by rate center falls outside of the +/-1% corridor, without sufficient justification, **fines will be imposed at \$250 per day**, for both the inpatient and outpatient data sets in accordance with COMAR 10.37.01.03, commencing with the first day following the data submission due date for each of the three quarters until corrected data are received. These fines will be imposed regardless of whether the quarterly data were submitted to St. Paul by the due date.

St. Paul is providing charges and volume reports by rate center along with the error reports after a hospital submits the initial case mix data. Any resubmissions made by hospitals after the final data submissions will be subject to a \$250 charge per resubmission/per quarter by St. Paul.
